INFORMATION REGARDING THE PROCESSING OF PERSONAL DATA

(LEGISLATIVE DECREE 196/2003 - ART. 13 EU REGULATION 2016/679)

In compliance with Legislative Decree n.196 of 2003 "Code regarding the protection of personal data" and the "European Regulation 2016/679" we provide you with the following information:

a) DATA CONTROLLER

The data controller is Ristorazioni Mugnai snc di Mugnai Giampiero e Villella Maria Rita e C., Via Cavalca n. 19, 56126 PISA, VAT number 01293750509, e-mail: info@ilcampano.com, PEC: ristorazionimugnaisas@pec.it, in the person of the legal representative.

b) PURPOSE OF THE PROCESSING

The collection and processing of personal data are carried out:

1.

to manage the requests for information received, acquire and confirm your booking (including access to the wi-fi network), and to provide the requested services. No special data will be processed unless the data is made manifestly public by the interested party – art. 9, paragraph 2.e. will be used only for the provision of the service (food intolerances – in this case if such data is not provided – anonymous – it will not be taken into account during the service). In case of refusal to provide personal data, we will not be able to confirm the booking or provide you with the requested services. The processing will take place for the time strictly necessary to achieve the purposes for which the data were collected, but some of your personal data may or must continue to be processed for the purposes and in the manner indicated in the following points; The mobile number may be used to provide you with information, including via WhatsApp, regarding the services;

for the purposes of protecting people, property and company assets through a video surveillance system of some areas of the facility, identifiable by the presence of specific signs. Your consent is not required for this processing, as it pursues our legitimate interest in protecting people and property against possible attacks, thefts, robberies, damage, acts of vandalism and for fire prevention and workplace safety purposes. The recorded images are deleted after 48 hours, except on holidays or other cases of closure of the business, and in any case no later than one week. They are not communicated to third parties, except in the case in which it is necessary to comply with a specific investigative request from the judicial authority or the judicial police;

3.

to comply with current administrative, accounting and tax obligations, including the request for invoicing. For these purposes, the processing is carried out without the need to acquire your consent. The data is processed by us and by our authorized personnel, and is communicated externally only in compliance with legal obligations. In the event of refusal to provide the data necessary for the above-mentioned obligations, we will not be able to provide you with the requested services. The data acquired for these purposes is stored by us for the time required by the respective regulations (10 years, and even longer in the case of tax audits);

4.

to send you our email messages or via WhatsApp on the initiatives proposed by us. For this purpose, after obtaining your consent (as specified below), your data will be stored for a maximum period of 5 years and will not be communicated to third parties. You can revoke your consent at any time.

Furthermore, PRIOR CONSENT, photos and videos of you may be taken for promotional purposes. The images/videos collected may be used and published and/or distributed, for purely promotional purposes of the Data Controller, on the magazines, on the Company's website, on social network pages and on any other social platform, always respecting decorum and honorability. The provision of consent to the processing of personal data is optional (therefore if you do not want to be photographed/filmed when the photos are taken, please move away).

c) DATA PROCESSING METHODS

In relation to the aforementioned purposes, data processing is carried out through automated tools, using electronic procedures and media, and/or manually for the

time strictly necessary to achieve the purposes for which the data was collected and, in any case, in compliance with the applicable regulatory provisions (article b).

The data is collected within the operational headquarters (ANTICA TRATTORIA IL CAMPANO) and related appurtenances, and processed in such a way as to guarantee the security and confidentiality of the data.

The data collected by the hostpost operator are not viewed by the Owner and in any way processed (except in the case of intimations and orders of the Judicial Authorities).

•

revoke consent, where given, without prejudice to the lawfulness of the processing based on the consent given before the revocation;

•

receive a copy of the data provided and request that such data be transmitted to another data controller.
