INFORMATION REGARDING THE PROCESSING OF PERSONAL DATA

(LEGISLATIVE DECREE 196/2003 and subsequent amendments - EU REGULATION 2016/679)

In compliance with Legislative Decree n. 196 of 2003 "Personal Data Protection Code" and subsequent amendments and "European Regulation 2016/679", we provide you with the following information:

a) DATA CONTROLLER

The data controller is Ristorazioni Mugnai snc di Mugnai Giampiero e Villella Maria Rita e C., Via Cavalca n. 19, 56126 PISA, VAT number 01293750509, e-mail: info@ilcampano.com, PEC: ristorazionimugnaisas@pec.it, in the person of the legal representative.

b) PURPOSE OF THE PROCESSING

The collection and processing of personal data are necessary for contractual purposes for the conclusion and management of the requested service, accounting and tax purposes dictated by law, and to maintain a supplier archive.

In detail, the data will be processed for the following purposes:

•

Supplier management (supplier administration; administration of contracts, orders, arrivals, invoices; selections in relation to the Company's needs)

•

Fulfillment of tax or accounting obligations

•

Litigation management (contractual breaches; warnings; transactions; debt collection; arbitration; legal disputes)

Furthermore, since a video surveillance system has been installed in some areas of the facility, identifiable by the presence of specific signs, your data or that of your employees/collaborators (images taken at the facility) may be processed for the purposes of protecting people, property and company assets through. Your consent is not required for this processing, as it pursues our legitimate interest in protecting people and property against possible attacks, thefts, robberies, damage, acts of vandalism and for fire prevention and workplace safety purposes. The recorded images are deleted after 48 hours, except on holidays or other cases of business closure, and in any case no later than one week. They are not communicated to third parties, except in the case of having to comply with a specific investigative request from the judicial authority or the judicial police.

c) DATA PROCESSING METHODS

In relation to the aforementioned purposes, data processing is carried out through automated tools, using electronic procedures and media, and/or manually for the time strictly necessary to achieve the purposes for which the data was collected and, in any case, in compliance with the current regulatory provisions on the matter.

The data is collected within the Company's headquarters and in any case processed in such a way as to guarantee the security and confidentiality of the data itself. The data will be processed by persons authorized by the Owner regarding the performance of the requested services.

d) OBLIGATION OR OPTION OF PROVISION

Information on suppliers

The provision of data is mandatory for all that is required by legal and contractual obligations and therefore any refusal to provide them in whole or in part may result in the impossibility for the Company to execute the contract or to correctly carry out all the obligations.

e) PLACE OF DATA PROCESSING AND POSSIBLE TRANSFER

The data will be processed within the European Union.

f) DATA RETENTION PERIOD

The personal data provided will be retained for the time strictly necessary to achieve the purposes for which the data were collected and, in any case, in compliance with the applicable regulatory provisions.

g) CATEGORIES OF SUBJECTS TO WHOM THE DATA ARE COMMUNICATED

The data may be communicated to subjects delegated to carry out the activities necessary only for the execution of the stipulated contract, but in no other case transferred, sold or bartered.

By way of example and not limited to:

1.

subjects recognized as recipients of the communication by national or community law, and by regulation (financial administration, etc.)

2.

other subjects, to whom the communication is necessary or functional to the performance of the Company's activity (e.g. credit institutions for accreditation)

3.

consultants and collaborators, to the extent necessary to carry out the task assigned by the Data Controller (collaborators of the Company, accountant for the completion of tax practices, etc.)

The external subjects to whom we communicate the data are appointed as external Data Processors or will operate autonomously as data controllers, where necessary. The list of external Managers can be consulted at the operational headquarters.

Obviously, we respond to the requests and orders of the Judicial Authorities, we collaborate in legal proceedings and comply with the provisions issued by Authorities and Supervisory and Control Bodies.

h) PROFILING

Your personal data are not subject to any fully automated decision-making process, including profiling.

i) RIGHTS OF THE INTERESTED PARTY

In relation to the data subject to the processing referred to in this information notice, the interested party is recognized at any time the right to:

•

receive confirmation of the existence of their personal data, know the purposes of the processing or their scope of circulation and access their content;

•

ask to update, modify and/or correct their personal data;

•

request the cancellation, transformation into anonymous form, blocking of data processed in violation of the law or the limitation of the processing of your personal data;

•

oppose for legitimate reasons the processing, including any profiling;

•

oppose the processing of data for the purpose of sending advertising or direct sales material or for carrying out market research or commercial communication;

•

revoke consent, where given, without prejudice to the lawfulness of the processing based on the consent given before the revocation;

•

receive a copy of the data provided and request that such data be transmitted to another data controller.

The exercise of the aforementioned rights may be exercised by written communication or communication to be sent to the email address info@ilcampano.com.

You also have the right to:

•

submit a complaint or report to the Authority for the Protection of Personal Data;

•

submit an effective judicial remedy against the supervisory authority;

•

submit an effective judicial remedy against the data controller or processor;

•

to give a mandate to a non-profit body, organization or association to exercise your rights;

•

to request compensation for damages resulting from the violation of the legislation.
