

# PRIVACY POLICY

In compliance with Legislative Decree no. 196 of 2003 "Personal Data Protection Code" and subsequent amendments and "European Regulation 2016/679" (GDPR), we provide you with the following information.

## 1. Data Controller

The data controller is Ristorazioni Mugnai snc di Mugnai Giampiero e Villella Maria Rita e C., via Cavalca, n.19 Pisa (PI), e-mail: info@ilcampano.com, in the person of the legal representative.

## 2. Data Protection Officer

The Company is not obliged to appoint a Data Protection Officer.

## 3. Purpose of the processing

By accessing and consulting this site, and using the services provided through it, users' personal data may be acquired, which, in compliance with current legislation on the protection of personal data, will be processed solely to pursue the following purposes:

1. purposes strictly connected and instrumental to allow access and use of the site, its functions and the requested services;
2. to fulfill any obligations provided for by law and European regulations;
3. for internal operational and management needs of the Data Controller and relating to the services offered through the site.

If the data collected should also be used for other purposes, for each possible further processing, users will be asked to express their consent. Only if the user freely and clearly consents to each further processing, then the data collected may be used.

## 4. Provision of personal data

1. The provision of personal data is mandatory for the purposes referred to in art. 3, paragraph a, as the legal basis of the processing is the execution of the services requested by the user, or the use of the site and any additional services expressly requested made available through the site. Any refusal to allow the related processing may therefore prevent the execution of the requested services; it will still be possible to consult the Site without providing any personal data, even if some functions may not be available and some services not provided.
2. In particular, the consequences of any refusal to provide your personal data will always be explicitly stated and specifically connected to each service: for example, any refusal to the related processing may prevent you from consulting the Site and its features (in the case of cookies). Therefore, the user will be adequately informed in the manner provided for each specific case, but in any case he or she may consult the Website even by denying consent to the processing of personal data, where required; in this case, some features or characteristics of the site may be disabled.

## 5. What data is processed?

Depending on the service provided, different types of personal data may be processed, as specified in this article.

**5.1 Navigation data** The computer systems and software procedures used to operate this website acquire, during their normal operation, some personal data whose transmission is implicit in the use of Internet communication protocols. This information is not collected to be associated with identified interested parties, but by its very nature could, through processing and association with data held by third parties, allow users to be identified. This category of data includes IP addresses or domain names of computers used by users who connect to the site, URI (Uniform Resource Identifier) addresses of the requested resources, the time of the request, the method used to submit the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response given by the server (successful, error, etc.) and other parameters relating to the operating system and the user's IT environment. These data are used for the sole purpose of obtaining anonymous statistical information on the use of the site and to check its correct functioning and are deleted immediately after processing. The data could be used to ascertain responsibility in the event of hypothetical computer crimes against the site: except for this eventuality, at present the data on web contacts do not persist for more than six months.

**5.2 Data provided voluntarily by the user (communications)** The optional, explicit and voluntary sending of communications by means of contact forms, **including the Booking service**, present on the site or by e-mail to the addresses indicated on this site, entails the subsequent acquisition of the data communicated by

the user, including his e-mail address, and consent to receive any response messages to his requests. These services allow us to manage an archive of e-mail contacts, telephone contacts or contacts of any other type, used to communicate with the user. These services may also allow you to collect data relating to the date and time the messages are viewed by the user, as well as the user's interaction with them, such as information on clicks on links inserted in messages. The personal data thus provided are used for the sole purpose of satisfying or responding to requests transmitted and are communicated to third parties only if this is necessary for this purpose.

**5.3 . “Messaging App: Whatsapp” Service** The user who intends to use the “Messaging App: WhatsApp” service on the Site, by clicking on the Whatsapp App connection button, sends a message to the owner of the site, with the purpose of requesting for example information, booking a table etc.. In particular, by filling in the text of the message with his/her data, he/she consents to their use to respond to requests for information, quotes, table reservations or any other nature indicated in the message. Personal data collected: Name and Surname, Telephone. The telephone numbers and data collected (name - surname) thus collected may be used by the owner of the site to send the customer/user, messages on the requested services.

**NATURE OF THE DATA PROCESSED** We process/will process exclusively your personal data, and they will be used for the sole purpose of performing the service or performance requested. Limited to the information released on this site, no personal data that can be classified as particular or of a judicial nature will be processed.

#### **5.4 Cookies**

This site uses cookies.

##### **What are they?**

Cookies are information stored by the browser when a website is visited with any suitable device (such as a PC, tablet or smartphone). Each cookie contains various data (e.g. the name of the server from which it comes, a numerical identifier, etc.), can remain in the system for the duration of a session (until the browser is closed) or for long periods and can contain a unique identification code.

##### **What are they for?**

Cookies are used for different purposes depending on their type: some are strictly necessary for the correct functionality of a website (technical cookies), while others optimize its performance to offer a better user experience or allow the acquisition of statistics on use of the site.

**LOG FILES AND THEIR STORAGE** Log files will be tracked for security reasons that require the registration and maintenance of log files and their accessibility by the judicial police in the event that the latter requests it. ## **6. Data processing methods**

Personal data are processed lawfully and fairly and used only for the purposes indicated in art. 3. Processing will be carried out using tools that are suitable for guaranteeing the security and confidentiality of personal data and with automated tools for storing, managing and transmitting the data. Specific security measures are adopted to prevent data loss and contain the risks of illicit or incorrect use and unauthorized access, and personal data will be stored for the periods prescribed by law and, in any case, for the time strictly necessary to follow up on the activities for which they were collected and/or until the consent given for the purposes referred to in art. 3 is revoked.

## **7. To whom can the collected data be communicated?**

1. The processing operations connected to the web services of this site take place at the Data Controller's headquarters and are handled only by technical personnel expressly authorized to process data, internal and/or external to the same. In particular, where necessary and only with prior consent, the data may be communicated to third parties whose collaboration the Data Controller may and/or must avail itself of for the performance of the services offered. The data acquired via the web, or in any case deriving from the web services, may be communicated to the technological and instrumental partners that the Data Controller uses for the provision of the services requested by the users, always in compliance with the purposes indicated in art. 3. To this end, the subjects who will have access to the personal data will be specifically authorized to process them by the Data Controller and, if necessary, appointed as Data Processors, pursuant to art. 28 and 29 of the GDPR and the Privacy Code.
2. The data collected for the purposes set out above may also be disclosed to persons authorised for this purpose by provisions of law and European regulations.
3. A list of the subjects to whom the Data Controller communicates the personal data collected for the aforementioned purposes may be requested at the addresses indicated.

## **8. How long is the data stored?**

The data is stored until the requested service is completed. In case of sending an e-mail or filling out the form to request information, the data is stored for the management of the request.

## **9. Where is the data processed?**

The data will be processed only within the European Union and the UK.

## **10. What are the rights of the interested parties?**

It is possible to exercise at any time the rights provided for by articles 15 and following of EU Regulation 679/2016 and of the Privacy Code and subsequent amendments:

1. receive confirmation of the existence of your personal data, know the purposes of the processing or their scope of circulation and access their content;
2. ask to update, modify and/or correct your personal data;
3. request the cancellation, transformation into anonymous form, blocking of data processed in violation of the law or the limitation of the processing of your personal data;
4. object for legitimate reasons to the processing, including any profiling;
5. oppose the processing of data for the purposes of sending advertising or direct sales material or for carrying out market research or commercial communications;
6. revoke consent, where given, without prejudice to the lawfulness of the processing based on the consent given before the revocation;
7. receive a copy of the data provided and request that such data be transmitted to another data controller.
8. If you have an account on this site, you can request to receive an exported file of the personal data stored on the site, including any data you have provided. You can also request that we delete all your personal data. This does not include any data we are required to retain for administrative, legal, or security purposes.

- to request compensation for damages resulting from the violation of the legislation.
